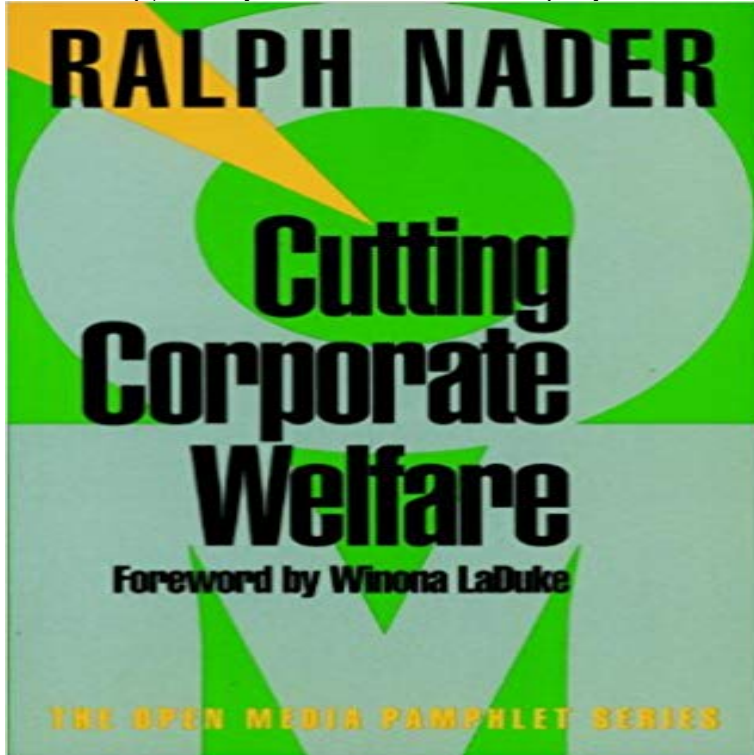


Cutting Corporate Welfare (Open Media Series)
