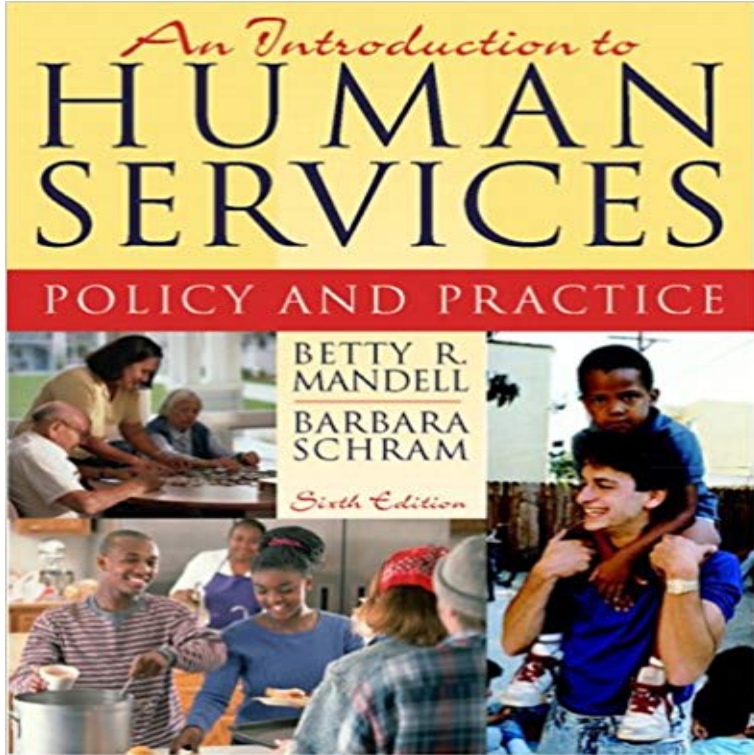


An Introduction to Human Services: Policy and Practice (6th Edition)
